#### **Government Liaison**

With there now being 10 different offices that process Exemption Applications we may find there are a few speed bumps along the way. #### **NCHENZ Constitution**

We've been reviewing the NCHENZ Constitution in order to update it with regard to the way NCHENZ now communicates with members (electronically rather than by post), that individual membership is free, and to reflect the way Committee meetings are held by teleconference, etc.

There are two aspects of the Constitution review which the Committee would love your input on:

Past Home Educators

The Constitution states that only current home educators can serve on the Committee. It can be beneficial to allow past home educators to join the Committee as they have valuable experience (and sometimes extra time) to contribute to NCHENZ. If the Constitution were changed to allow past home educators to serve on the Committee, there are some things which would need to be clarified – such as, what percentage of the Committee can be past home educators vs how many need to be currently home educating; how long ago should the past home educator have held a Certificate of Exemption for their child; does it matter if they stopped home educating to put their children in school, or do they need to not have children in school ...? *Group Membership* 

The other aspect of the Constitution review is where group membership fits, with regard to regional and local home education support groups. Currently groups pay a membership fee of \$25 per year. Traditionally the number of group members has been low, currently NCHENZ has eight group members. Should group membership be free so that any group can join and benefit from information sharing and extended networking?
